PARA TWO ADMITS TO THESE ACTS WITH ALL OF THE ABOVE PD ALL EXCEPT DENY SUCH ACTS WITH PD THEY EITHER ADMIT TO SIMILAR ACTS WITH OTHER PERSONS OR DENY ANY SUCH CONDUCT PD ALTHOUGH ADMITS GROSS INDECENCY AND SODOMY WITH HE CONTRADICTS AS TO THE TIMES AND PLACES
