1. Acting on instructions of the Area Provost Marshal, Calgary Garrison, and information received from the adjt 1 GOR of B, an investigation was opened into the alleged indecent sexual relationship between [redacted] RCANMC att 1 GOR of C, [redacted] GOR of C Depot and [redacted] GOR of B Depot.

2. The following is a brief outline of events which led to this incident being reported to this Detachment:

- (a) Training NCOs of GOR of C Depot were made aware that some of the recruits had been indecently molested by an unknown Opl in the RCANMC.
- (b) GOR of C Depot held a Commanding Officers' Investigation where it was brought out that [redacted] and [redacted] had had indecent sexual relationship with a Opl in the RCANMC whom they did not know by name but could identify.
- (c) Through inquiries made by GOR of C Depot, it was believed that the RCANMC Opl in question was Opl [redacted].
- (d) As [redacted] is attached to 1 GOR of C the investigation was turned over to that unit.
- (e) The adjt of 1 GOR of C turned the investigation over to this Detachment.

3. At about 0945 hrs, 22 MAY 59, I interviewed Rfn [redacted] at Calgary Provost Detachment. [redacted] made a voluntary statement in which he said that, on Saturday night during the Easter holidays, he met a man in the Bus Depot. At this man's invitation he accompanied him to room 213 at the Noble Hotel, after the man had bought some liquor. Whilst in the room the man made sexual advances and then committed an act of fellatio on [redacted]. Later in the evening he again met this man and returned to the hotel room with him. [redacted] then got drunk and when he awoke in the morning he found himself nude in bed. He added that he felt very dirty all over and sore around the rectum. [redacted] said that he had seen the man at the MIR and that he is a Medical Corporal. See ANNEX 1.

4. At 1145 hrs, 22 MAY 59, I interviewed [redacted] at the Calgary Provost Detachment Office. [redacted] made a voluntary statement. He said that one afternoon he was told to report on special sick parade, he was met at the MIR by a Medical Corporal and told to go into an examining room and undress.

The Corporal then entered the room, locked the door and put his arms around [redacted]'s waist. About two weeks later [redacted] was back on sick parade. At this time the same Corporal got him into the examining room where he committed an act of fellatio on him. See ANNEX 2.

5. At 1225 hrs, 22 MAY 59, [redacted] 1 W/O of C was interviewed at the Calgary Provost Detachment Office. [redacted] stated that one day last month he was on sick parade. Whilst at the MIR a Medical Corporal grabbed him by the penis and [redacted] told him to stop, which he did. See ANNEX 3.

6. At 1205 hrs, 22 MAY 59, [redacted] W/O of C Depot, was interviewed at the Calgary Provost Detachment Office. [redacted] said that on the previous Sunday, whilst on defaulters, he had been detailed to clean the Corporals' Mess. He was sent by the Opl 1C Detail to the canteen to get some cigarettes. When he returned, the Corporal grabbed his private parts and told [redacted] he would give him some beer if he would let him see it. [redacted] resisted and nothing more happened. See ANNEX 4.

7. As all these men believed they could identify the Medical Corporal, an identification parade was held at 1300 hrs, 22 MAY 59, at SCOTT HALL, CURRIE BARRACKS, CALGARY, Alberta. The officer in charge of the parade was [redacted] 1 W/O of C. The parade consisted of twelve (12) RCAMC Corporals of equal height and stature, all were dressed alike. [redacted] and [redacted] identified the Corporal, they alleged had indecently assaulted them, to be an RCAMC, attached to 1 W/O of C, CURRIE BARRACKS, CALGARY, Alberta. Each man identified Opl [redacted] twice.

8. At 1340 hrs, 22 MAY 59, [redacted] was cautioned and interrogated at the Calgary Provost Detachment Office. [redacted] made a voluntary statement in which he said that it all started two years ago in GERMANY when he was drinking with some British Soldiers. They had started to grab each others private parts, then one of the soldiers committed an act of fellatio on [redacted]. They continued this practice frequently. [redacted] then came to CALGARY and started doing it with recruits, the first one was [redacted] added that in the hotel room with [redacted] they had masturbated each other. The next one was [redacted] while in the MIR [redacted] committed an act of fellatio on [redacted], and [redacted] masturbated him. See ANNEX 5.

9. Due to discrepancies in the statements, [redacted] was re-interviewed at the Calgary Provost Detachment Office at 0900 hrs, 23 MAY 59. At this time he admitted masturbating Opl [redacted] at the Noble Hotel, but declined to change his previous statement. It is understood that [redacted] is being released from the CDN Army under WR Army Item 5 B (2) shortly, as unlikely to become an efficient soldier.

10. At 1045 hrs, 23 MAY 59, [redacted] was re-interviewed at the Calgary Provost Detachment Office. He said that at the time [redacted] was committing an act of fellatio on him, he [redacted] was also masturbating himself. [redacted] denies touching [redacted] in any way.

11. It was felt that [redacted] was not telling the full story concerning his relationship with [redacted]. It is believed that he may have homosexual tendencies and should be referred to the Medical Officer for psychiatric examination. His answers relating to sexual matters were very evasive, and he displayed abnormal reactions.

12. In conclusion the following points are brought out:

- (a) [redacted] was identified by four (4) people as the RCMP Cpl who had indecently molested them.
- (b) [redacted] has admitted his indecent behavior.
- (c) [redacted] and [redacted] appeared to be homosexually inclined, and should be referred to Medical Officer for investigation, if retained in CA(R)
- (d) [redacted] and [redacted] were not involved and resented [redacted]'s advances.

13. As no further action is deemed necessary, this file will be considered concluded, unless otherwise directed.
