1 Hereunder at flags (1), (2) and (4) are further investigation reports received from WSIU and FSIU in this connection.

2 You will note in [redacted]'s statement contained in para 5 of report at flag (1) that when asked to describe the acts of homosexuality he admitted having committed with [redacted] he replied that they were "at the most buggery" and that [redacted] was the aggressor. It is interesting to also note in para 3 of WSIU covering letter at flag (2) that the SMO at Stn Cold Lake expressed the view that fallatio, sodomy and other homosexual acts were committed between [redacted] and [redacted]. In a further and much more detailed statement made under caution to FSIU investigators (Appendix "A" to report at flag (4)), [redacted] mentioned the numerous instances and places where he and [redacted] engaged in their homosexual activities, and stated that such activities consisted of only "mutual masturbation" and "kissing".

3 You will further note report at flag 4 (para 4 and statement at Appendix "B") that [redacted] admitted his alleged homosexual activities with [redacted], and further admitted having committed mutual acts of oral copulation and masturbation with two other fellow officers who have been identified as being [redacted] Air/Ops who is now on rehab leave, and [redacted] Air/Pilot who is still serving and on strength of RCAF Stn Comox. Both these officers are single and were cleared Secret on 4 Dec 57 and 29 Nov 55 respectively.

4 With regard to the underlined portion of [redacted]'s statement at Appendix "A" to report at flag (4), the alleged self-admitted homosexual has been tentatively identified as [redacted] Ftr/Ops now serving at [redacted]. He was cleared Secret on 14 Mar 57.

5 It remains to be seen now what action Stns North Bay and Cold Lake take regarding [redacted] and [redacted] respectively. No doubt they will be released under CAFAO C34.00/54.

6 As for [redacted], I recommend that the following action be taken:

- (a) Request WSIU to proceed to Stn Comox with a view to interviewing [redacted] regarding [redacted]'s self-admitted homosexual acts with him; and
- (b) Brief DAFS and request that [redacted] be returned to Canada (preferably Ottawa) for interrogation.

The case against [redacted] is rather nebulous, there does not seem to be enough certainty here to return [redacted] from NORAD.

AFS 2-3 will take action through CFMS (S/L Russell) to determine the medical disposition of [redacted], if any, and keep you advised.
