ing the incident was due to his position and embarrassment.

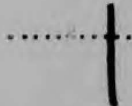

Statement of [redacted] continued

At this time I was feeling no pain what so ever as I had consumed a large quantity of beer while watching the hockey game and my senses of just what was about to happen and just what I was doing were somewhat not sharp.

Waiting approximately 10 minutes for the supposed girls [redacted] talked of nothing but how he was feeling so over-excited. He then moved over to my side of the car and started to touch my private parts. He then started to take my penis out of my pants and it was about this time that I gathered enough of my senses together to tell him to get lost and I then immediately headed back to camp. At the junction of Hwy 11 and 103 I saw

[redacted] hitch-hiking and stopped to pick him up. [redacted] then started to talk to [redacted] about how he knew where to get a bottle of liquor and asked [redacted] if he wanted to go drinking with him. I had said no while after picking up [redacted] and remained silent on 11 letting [redacted] off at RR 13. [redacted] and myself then went back to town where I told him the above story.

Statement of [redacted]

Begins:

At approximately 1500 hrs on the evening of 17 Apr 62, the writer and [redacted] left the airman's mess canteen to proceed down town. Outside the canteen [redacted] was approached by [redacted] and asked for a ride down town to which [redacted] agreed.

On the way down [redacted] who was seated in the back seat introduced himself to the writer and stated that he was a Porcupine at Stn North Bay. He then started talking to [redacted] and stated he had two girls waiting for him some place in town and that he needed another fellow as his friend hadn't shown up. [redacted] then decided he would go with [redacted] as he wanted a date. [redacted] dropped the writer off at the Delcar restaurant in North Bay, at which time [redacted] got in the front seat.

The writer then decided not to go in the restaurant but to try and hitch a ride back to the base. Having not been able to get a ride the writer had walked to the corner of highway 11 and 103 which had taken approximately 30 minutes, when [redacted] came along and picked the writer up. [redacted] then [redacted] stopped [redacted] got out of the front seat and got into the back. [redacted] [redacted] and the writer then proceeded to the base where [redacted] was dropped off at RR 13. The writer and [redacted] then proceeded down town where [redacted] told the whole story of [redacted] [redacted] had tried to do to him.
