2 On this date I contacted the Unit CO, [REDACTED] and the WO i/c AFP, [REDACTED] and was briefed regarding the matter to be investigated. It was learned that on 28 Apr 65, [REDACTED] (AFP) had reported to the WO i/c AFP that he had been sexually molested by [REDACTED] (AFP) at about 0200 hrs, 28 Apr 65. Upon ascertaining the probable validity of this allegation [REDACTED] was relieved of his AFP duties and credentials and had his name deleted from the HRP Master List on authority of the CO. This matter was reported to ADHQ via confidential message M383 d/29 Apr 65. The subject is presently employed in the Unit CE Section stores.

4 On 3 May 65 I interviewed the complainant in this case, (APP). It was learned that [REDACTED] is a new arrival at Stn La Macaza having been TOS from Stn St Margarets on 12 Apr 65. His DOB is [REDACTED]. With the exception of one minor charge dealing with the misuse of a DND vehicle no adverse information was located in Unit files. The following voluntary statement was obtained:

3 May 65  
Stn La Macaza, PQ

I am [REDACTED] employed as an APP at Stn La Macaza. I wish to state the following regarding an incident which occurred at about 0200 hrs, 28 April 1965. I was awakened by my roommate, [REDACTED] who was caressing my neck and ears with his hands. I told him to leave me alone. He then grabbed my wrists and told me I wasn't going to get any sleep for awhile. I struggled with him for a couple of minutes when [REDACTED] entered the room, he thought we were just fooling around so he left the room. At this time I didn't think that [REDACTED] was serious so I didn't say anything to [REDACTED]. We struggled again for a few seconds and [REDACTED] said, "do you want me to seduce you or do I have to rape you". I started to struggle again as he had both of my wrists pinned down. I managed to get one wrist free and tried to push him away, however, he is much stronger than me so I wasn't successful. He started to reach under the covers and grabbed me by the thighs. All this time I was struggling. I threw him off balance and he grabbed my wrists again. He put my arms behind my back and pushed me against the wall. This same sort of thing, that is, grabbing my upper legs and muzzle my neck with his face went on for about five minutes and I was getting madder. At this time I was wearing a Tee shirt and shorts. He let go of my right arm which was wedged under me and held the left arm, he put his left arm on my chest to hold me down and the next thing I knew he had his right hand in the top of my shorts. I brought my knees up as hard as I could, struggled free, and pushed him away. He got up and went to his own side of the room and took his Tee shirt and trousers off. I got out of bed and went to sleep in a spare room. It is my opinion that [REDACTED] was fairly intoxicated during this incident. I also believe that his assault on me was an actual homosexual attempt and not mere horseplay. I had only lived in this room with [REDACTED] since 12 Apr 65 when I was [REDACTED]. I had the impression that he was a very quiet person and did not expect this type of behaviour from him. I reported this incident to the WO i/c APP at about 1000 hrs the same date.

..... I remember when I first came to this Unit that some APP, whose name I can't remember, warned me that [redacted] might try to put the "make" on me. [redacted] does not to my knowledge have any female friends and is inclined to be a "loner". I also remember that while we were struggling on the bed [redacted] kissed me once behind the right ear. The entire incident frightened me and revolted me.

5 I next interviewed [redacted] (APP), Stn La Macaza, who witnessed a portion of the above mentioned assault. The witness's DOB is [redacted] and a review of Unit files revealed no adverse information concerning him. The following voluntary statement was obtained:

3 May 65  
Stn La Macaza, P.Q.

I am [redacted], employed as an APP at RCAF Stn La Macaza. I wish to state the following regarding an incident that occurred in the Airmen's barracks (room 95) at about 0130 hrs, 28 Apr 65. [redacted] (APP) and myself were playing cards in his room when [redacted] entered the room and asked if anyone wanted to go downtown with him. We said "no". He had a pint of beer, he drank that and left for his room which he shared at that time with [redacted]. I went back to my room which is across the hall from room 95. I heard [redacted] moaning and groaning. I went into the room and saw [redacted] sitting on [redacted]'s bed holding [redacted] s wrists. [redacted] was dressed in a Tee shirt and trousers at this time and [redacted] I would assume was undressed as he was under the bedcovers. I left the room and went back to bed. I heard [redacted] making fairly loud noises for about half an hour. The same day at about 1100 hrs, [redacted] told me that [redacted] had been caressing his neck, rubbing his chin on his chest, and had his hand in his undershorts. He also said that he hit [redacted] in the eye.

6 I next contacted [REDACTED] Stn La Macaza PQ, who had allegedly been bothered by [REDACTED]. [REDACTED] S DOB is [REDACTED] and a check of Unit records revealed that no adverse information is on file regarding him. The following voluntary statement was obtained:

4 May 65

Stn La Macaza, P.Q.

I am [REDACTED] employed as an APP at Stn La Macaza. I wish to state the following regarding an incident which occurred to me in about Jan or Feb 1965. I was in my bed in barracks (room 91) at about midnight when [REDACTED] entered and asked me to go downtown with him. He had been drinking. I told him that I didn't want to go. He grabbed me by the arm and tried to pull me out of bed but I wouldn't move. I thought he was just fooling and wanted to wrestle. He laid on top of me on the bed (I was under the covers) and started to rub his chin against my chest. I told him to leave me alone and he grabbed my arms and pinned them down and continued to rub his chin on my chest. My roommate came into the room at this time so [REDACTED] got off of me. I didn't bother to report this incident at this time as I thought he was only joking. However, in view of another incident of this nature which has occurred recently I am of the opinion that perhaps [REDACTED] has homosexual tendencies.

7 I next interviewed [redacted] (APP),  
Stn La Macaza PQ who had also allegedly been bothered by [redacted]  
[redacted] S DOB is [redacted] and a review of Unit  
files revealed no adverse information concerning him. The  
following voluntary statement was obtained:

4 May 65  
RCAF Stn La Macaza PQ

I am [redacted], employed as  
an APP at Stn La Macaza, P.Q. Approximately  
six or seven months ago I was sleeping in my  
room (#87) in barracks at about 0200 hrs. I  
was awakened by [redacted] (APP) who  
jumped half on me and half on the bed and  
started jabbing me in the waist and grabbing  
me by the arms. I woke up and told him to  
leave me alone and leave the room. He said,  
"fuck you, [redacted], and left. At the time I  
was annoyed but I did not think too much about  
the incident as [redacted] had been drinking.  
At this time I had heard that [redacted] had  
awakened other airmen in this manner but I did  
not pay any attention to it. However, in view  
of the fact that it has happened more than  
once I would think that [redacted] needs some  
help from a Doctor. The reason I didn't take  
any notice of these incidents is that [redacted]  
is a "loner" and I thought he was  
trying to become friendlier with his fellow  
workers.

8 It was learned from [redacted] (APP), (para 5), that  
[redacted] may have made advances towards another airman who  
had been on TD at Stn La Macaza from Stn Chatham for about a month  
commencing 22 Feb 65. This airman identified as [redacted]  
[redacted] shared a room with [redacted] during this period.  
Arrangements have been made by [redacted] to have [redacted] who is an APP,  
interviewed by an investigator from SID Moncton. The results of  
this enquiry will be included in our next report.

9 Perusal of [redacted]'s personal files indicated  
that he enlisted in the RCAF on [redacted] and was enrolled in the  
Cikam trade. He remustered to the APP trade at Stn Trenton on  
1 Mar 56. The subject was TOS Stn La Macaza from Stn Gypsumville  
on 11 Nov 63. On 12 Dec 64 he was convicted under section 118 of  
the NDA for reporting for duty in a drunken condition and awarded  
a \$10.00 fine. On 12 Mar 65 he was prohibited from drinking on  
the Unit for a six month period by the CO. This period of inter-  
diction resulted from an incident in the Airmen's canteen on 11  
Mar 65 during which the subject was behaving in an abusive and  
offensive manner towards [redacted]

10 Enquiries on the Unit indicated that the subject is a shy, introverted individual who talks infrequently and stays to himself when sober. However, when he is drinking this pattern reverses itself and he becomes high spirited and gregarious. He has no known female friends in the La Macaza area and spends a considerable amount of his off duty hours frequenting local bars with the younger single APP personnel.

11 On 5 May 65 I interviewed [redacted] and advised him of the allegations that had been made against him. He denied having any homosexual tendencies and offered the explanation that he just liked to "wrestle" when he was drinking. This NCO, who is 29 years old, (DOB [redacted]) is very well developed physically and gives all outwards appearances of masculinity. The subject has never been married and told me that he has not had a girlfriend since joining the RCAF in 1955. He added that he utilises prostitutes occasionally. He stated that he mistrusted women generally. He believes that this mistrust is due to the fact that [redacted]

[redacted] when he was two years old. He went to live with his grandparents who [redacted] when he was seven years of age. He lived with his grandmother until he was fourteen at which time he left home to seek employment. He added that a number of his married friends in his home town of Fredericton NB were having marital difficulties and he feels that if he marries he would have similar problems. I cautioned [redacted] in accordance with QR (Air) article 101.12 (3) and received the following voluntary statement:

Stn La Macaza, P.Q.

I am [redacted] employed as an APP at Stn La Macaza. I have been advised by Sgt M. Allan of the Investigation Unit of allegations made by [redacted] regarding an alleged homosexual attempt against him by me on 28 April 1965. I neither confirm nor deny this allegation.
