1. On 15 Feb 80, information was recyived from Maj Boileau, LdSH(RC), to the effect that two members of his mit had been found in circumstances that suggested that they were involved in a monosexual act.

2. On 16 Jeb 80, about 1100 hrs, , was contacted and interviewed. During this interview he provided a written statement, and the following information concerning this alleged homosexual act. A copy of his statement is attached (Annex "A") and contains the following relevant points:

- a. that one of his troop members had reported to him of having witnessed a homosexual act, which took place at about 2250 hrs, 14 Feb SJ, iu a room in
- b. stated that he had seen drinking excessively earlier in the evening, and he had seen passed out on bed (another mymber of his troop) about 1930 hrs that evening (14 Feb 80):
- c. had entered is room serlier during the evening about 2100 hrs, to pick up a radio, and he saw passed out on his own bed, and he was still full, clothed, no one size was in the room at that time;
- d. evening about 2250 hrs, 14 Feb 20, to pick up a thermos, and when he operad the door to enter the room, he saw two naked male members of his troop on a bed in this room;

- f. when entered the room, jumped off the bed, and slumped dorward onto his bed;
- 8. when had picked up the thermos and was about to leave the room, had said to him "don't tell anyone, about this" to which replied "yes";
- h. had stated that in his opinion must have been helped to his own hed, because he (would not have been able to get there by himself ewing to his intoxicated state; and

5. At about 1345 hrs, 16 Feb, was contacted and interviewed. He provided a written statement which is attached as Annex "B". The following relevant information was obtained from this statement:

- that at about 2250 hrs, 14 Feb 80, he walked through the door, which joins his room and 's room. At this time he noticed on his bed on all fours, and was on his knees behind him; both were naked; a.
- b. immediately jumped off the bed when he came into the room;
- c. did not may anything, but he just slumped forw rd face first onto his bed;
- in his opinion was totally drunk and unaware of his actions because he had seen 1 earlier in the evening drinking excessively. was in such an intoxicated state that his legs were buckling as he tried to walk; d.
- as he was about to leave 's room, asked him not to tell anyone what he had seen; and ...
- f. he had confided in two other members of his theop because he wanted their advise on what be do. They all decided that it would be that to contact the Chaplain. However, as he couldn't contact the Chaplein, he later informed his troop officer

4. On 15 Feb 80 at about 140C hrs, a check of 's personal file was carried out. Two letters on his file indicated that he was involved in a previous homosexual act - SIU Calgary report SWC 140-1-79 dated 30 Jan 79 refers. These letters show that was involved with , and that this occurrance took place at A-19 Sarces Barracks. However, the medical officer stated at that time that this was an "isolated" incident which is unlikely to be repeated. Comies of the two letters are s' hed as innexes"C"and "D".

5. On 18 Feb 80, at about 1425 hrs, was interviewed regarding his part in this report homosexual act. He provided a statement which is stated as innex "E", and the following information was obtained from him:

- a. that he finds it hard to believe that anyone would say such a thing about him; and
- b. that he has never been involved in any sort of homosexual act, and finds it disgusting that anyone would say or even imply such a thing.

It was noted during this interview, completely denied any knowledge that this homosexual act had taken place. He emphatically stated that it couldn't have taken place.

C. On 18 Feb 80, at about 1610 hrs, was incorviewed. His written statement is stached as innex "F", at the "cllowing information was obtained:

- a. be had usen drinking in the Junior Ran's Club in Juring the evening of 14 Feb 80, and that he had met Martineau there. Sometime later he left the club with and several other friends and proceeded to room, wasre passed out on bod;
- b. a short time later two members of his troop carried to his own room. He (accompanied them because he had the key to this room. He then returned to Colling room;
- c. still later in the evening he left room and headed for his own room, however, as he came to a room, he entered the room to place the key on the table;
- d. while in the room he undressed and then he got undressed himself. He turned off the room light and then performed a homosexual act on "he described this act as the insertion of his penis into sown words");
- e. had entered the room, while he was engaged in this act and he then jumped off the bed. He confirmed that had entered the room to pics up a thermos and that he had asked ! "not to tell anyone" as he () was leaving the room;

It is also noted that in 's opinion, was intoxicated earlier in the evening of the 14 Feb 80 at the JRC, and was intoxicated when Found him in the room with at 2250 hrs 14 Feb 80. Stated that, while asked him the questions as stated above, "He had a furmy look in his eyes." I have read over the above statement and it is true, to the best of my knowledge.






