1. REF B PRESCRIBES POLICY IN CF AS IT PERTAINS TO CASES INVOLVING ALLEGED HOMOSEXUALS QUOTE SERVICE POLICY DOES NOT ALLOW HOMOSEXUAL MEMBERS OR MEMBERS WITH A SEXUAL ABNORMALITY TO BE RETAINED IN THE CF UNQUOTE. REF B ALSO PROVIDES ADM MECHANISM WHEREBY A DETERMINED HOMOSEXUAL MAY BE REL. IT IS APPRICIATED THAT AT UNIT LEVEL EXPEDITION OF THESE CASES IS OF PRIME CONCERN. THE URGENCY SHOULD NOT HOWEVER BE AT THE EXPENSE OF THE MIN STAFFING REQUIREMENTS IAW CFAO 19-20

2. REF B PARA 8 PROVIDES THE MIN STAFFING REQUIRED AND THAT IS CO INVESTIGATION AND RECOMMENDATIONS TOGETHER WITH COPIES OF MED AND SIU REPORTS TO COMMAND. NOTWITHSTANDING NDHQ HAS BEEN RECEIVING MESSAGES FROM UNITS RECOMMENDING A MEMBERS S IMMEDIATE REL SOMETIMES DIRECTLY VICE THRU COMMAND THAT PURPORT TO SATISFY PARA 8 BUT DO NOT INCL A MED REPORT AND ARE VERY LIMITED AS FAR AS BACKGROUND INFO FROM A CO S INVESTIGATION. THESE MESSAGES DO NOT SATISFY THE REQUIREMENT OF PARA 8 REF B
