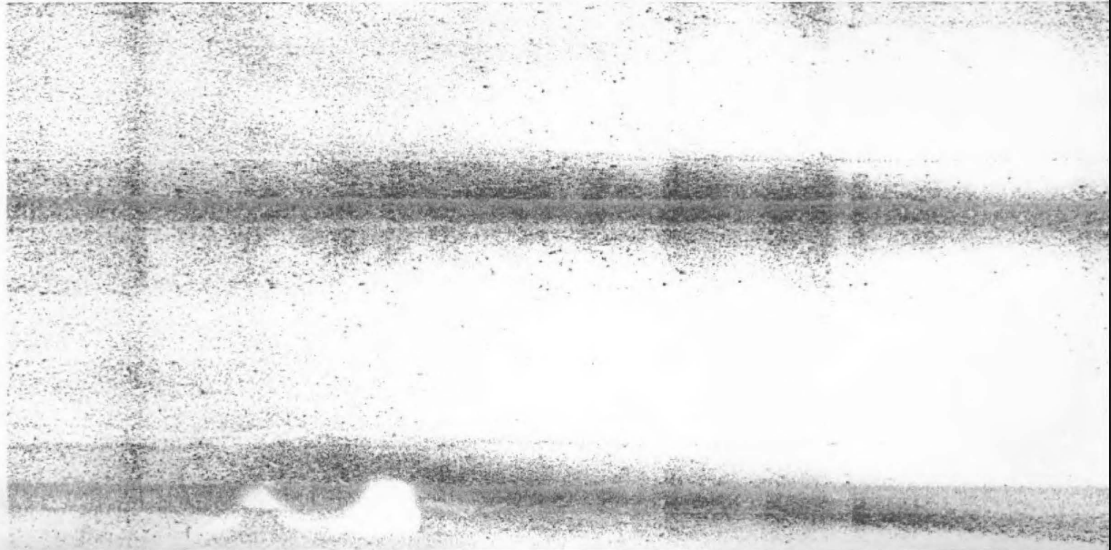

3. Accordingly we should demand that the tape (illegally acquired) be distributed to everyone in attendance who was quoted, to allow for corrections, amendments and deletion of "off the record" comment, opinion or statements without changing the substance or intent of the input.
4. In addition, the original tape, plus any copies, plus this original transcript should be destroyed.
5. I doubt that I personally would make too many amendments or corrections, but perhaps may achieve a reduction in the "logorrhoea".
6. I am sure both Cmdre Crickard and Mr Digby may wish to rephrase comments which came across differently when heard in that open forum to what they appear as in cold print.


