4	DS: 110-18-76	Security - Homosexuality Quebec City	This case involves a Sgt and a Pte who works for him. The Sgt told the Pte "that he (Pte) could get promoted fast as he knew a high ranking officer with influence". One female US servicewoman was verbally threatened by a Cdn Pte re: a statement "US Cdns stick together, so you better watch out".
