AT THIS TIME THEY ASKED ME TO PUT DOWN IN WRITING ALL MY ACTIVITIES, OF PRIVATE AND PERSONNAL NATURE AS WELL AS NAMES OF PEOPLE WHO KNEW ABOUT ME BEING A HOMOSEXUAL WITH SPECIFIC INTEREST ON NAMING PERSONS IN THE SERVICE I AGREED TO PUT IT DOWN IN WRITING IN ORDER TO KEEP MY SECURITY CLEARENCE WITH IS IMPORTANT TO MY TRADE. AFTER WHICH I HAD AN INTERVIEW WITH MY DCO "DEPUTY COMMANDING OFFICER" WHO EXPLAINED TO ME THAT, THEY WOULD HAVE TO REMOVE MY SECURITY CLEARENCE BECAUSE IN CFAO (CANADIAN FORCES ADMINISTRATI ORDERS). IT IS A CRIMINAL ACT AND THAT I WOULD BE OUT OF THE SERVICES IN A MONTH. THAT WAS FIVE MONTHS AGO. AT THE PRESENT TIME I AM WORKING IN AN UNCLASSIFIED SECURITY AREA. THAT HAS NOTHING TO DO WITH MY TRANNING OR QUALIFICATIONS. I WOULD LIKE VERY MUCH TO GET BACK TO THE WORK I AM QUALIFIED TO DO.

I HAVE NEVER NOW OR EVER IN THE SERVICE OF MY COUNTRY JEOPARDIZE THE SECURITY. I DO NOT MIX MY MILITARY LIFE WITH MY PRIVATE LIFE.

I FEEL I HAVE BEEN DISCRIMINATED AGAINST BECAUSE OF MY SEXUAL ORIENTATION AND I AM NOT BEING TREATED WITH EQUAL RIGHT AS STATED IN THE CANADAIN CONSTITUTION.

I WOULD APPRICIATE ANY HELP THAT YOU COULD GIVE ME RESOLVE THIS SITUATION. IF THERE IS ANITHING ELSE I CAN DO FEEL FREE TO CONTACT ME AT ANY TIME. YOU HAVE MY THANKS AND APPRECIATION.
