IF AN INDIVIDUAL WHO IS SUSPECTED OF BEING INVOLVED IN HOMOSEXUAL ACTIVITIES OR OF HAVING DEMONSTRATED A SEXUAL ABNORMALITY APPLIES FOR VOLUNTARY RELEASE, SUCH RELEASE SHALL BE DELAYED UNTIL THE INDIVIDUAL IS EITHER CLEARED OR THE ALLEGATION IS SUBSTANTIATED AND HAS BEEN CONSIDERED BY A SPECIAL CAREER REVIEW BOARD (SCRB) AT NDHQ. IN THE LATTER CASE, A RECOMMENDATION WILL BE SUBM TO ADM(PER) FOR APPROVAL, INCLUDING THE MOST APPROPRIATE RELEASE ITEM IF THE MEMBER IS NOT TO BE RETAINED
- 3. REF B REMOVED INVESTIGATIONS OF HOMOSEXUALITY AND SEXUAL
  ABNORMALITY AS EXCLUSIVE ITEMS FROM THE MANDATE OF THE SIU.
  COMMANDING OFFICERS ARE STILL REQR TO INVESTIGATE ALLEGATIONS OF
  HOMOSEXUALITY. OWING TO THE SENSITIVITY OF THIS ISSUE, SUMMARY
  INVESTIGATIONS AND BOARDS OF INQUIRY ARE NOT RECOMMENDED. WITH THE
  EXCEPTION OF HOMOSEXUAL ACTS WHICH DO NOT CONTRAVENE THE CRIMINAL CODE
  OF CANADA, (FOR EXAMPLE, ARE NOT COMMITTED IN PUBLIC, DO NOT INVOLVE A

- 4. SEXUAL ABNORMALITY OFTEN RESULTS IN CRIMINAL PROSECUTION. ONCE REASONABLY CERTAIN OF A SERVICE MEMBER'S HOMOSEXUALITY OR SEXUAL ABNORMALITY, A CO MAY FORWARD RECOMMENDATIONS BEFORE THE CONCLUSION OF CIVIL PROCEEDINGS IF HE OR SHE DEEMS IT APPROPRIATE. THE KEY FACT IS THAT THE INDIVIDUAL HAS BEEN FOUND GUILTY, ALTHOUGH NOT CONVICTED OF AN OFFENCE, WHICH IS SUFFICIENT TO JUSTIFY ADMINISTRATIVE ACTION. WITH A CONVICTION, THE COURT MAY SUSPEND THE PASSING OF SENTENCE AND DIRECT THAT THE ACCUSED BE RELEASED ON THE CONDITIONS PRESCRIBED IN A PROBATION ORDER
