Security Cases Involving Character Weaknesses Draft Paper for Security Sub-Panel

- considered in some detail in the draft paper, certain other character weaknesses are encountered as frequently by security officers, eg, criminal tendencies, immorality, indebtedness and mental illness. In fact, cases involving stability and other psychiatric disorders are no longer the exception and are far more prevalent than those involving homosexuality. In such cases a decision as to restriction or refusal of clearance can and should only be made after expert (medical) advice has been received. A character weakness such as persistent immorality especially on the part of a female employee may be only a question of personnel selection and not of security but at the same time such conduct could be indicative of such instability as to be a security matter.
- 2. A decision to withhold or restrict clearance is never based on a single act but is taken after a well-defined pattern of conduct has been established extending over a considerable period of time. Even then, in many cases, it is the intention of the clearing authority that the restriction be removed as soon as the individual demonstrates that he has overcome the particular defect or weakness. For example, in certain cases the clearance will read "granted clearance to CONFIDENTIAL only at this time". In many cases it is suggested that the clearance be reviewed after a period of time, say two years, with the view to upgrading. To a certain extent the suggestion contained in para 8 of the draft paper is now in operation in the Department of National Defence (Army), and in some cases the employee's superior officer is instructed to counsel the employee or soldier in respect to his drinking habits, indebtedness, etc.
- A review of cases where an individual's clearance has been restricted or refused shows that only in a very few exceptional cases has this action resulted in loss of employment for the individual. Satisfactory employment on unclassified work or in positions giving access to less highly classified information has always been found for these people. In the few cases where the individuals have been released, they would have been dismissed or released in any event on the basis of unsatisfactory service even if the security factor was not involved.

c. Subject has had the following civil convictions -

Subject retained in unit and employed on work where he does NOT require access to SECRET information.

- Oct 55 driving while impaired-Fined \$75.00 and costs.
- Nov 55 careless driving-Fined \$15.00 and costs.
- Sep 49 charged with being drunk and disabled. Charges withdrawn as Subject had been injured in accident arising from his condition.
- d. Has shown irresponsible attitude towards his legal debts.

CASE II

Debts

- a. Indebtedness, sufficient to promote his release from CA (R) in Sep 54.
- a. Subject had SECRET clearance while in CA(R).

Criminal Convictions

- b. Sep 55 2 charges false pretences - sentenced one month in gaol on each.
- c. Apr 56 convicted on 4 charges of false pretences.

b. Applicant for civilian position of draftsman car requiring clearance to CONFIDENTIAL or higher-clearance refused. Applicant NOT accepted by DND.

CASE III

Mental Illness

Subject has history of mental illness over several years incl shock treat-ment in 1954 - diagnosed as "Menic Depressive Psychosis - later as acute and severe anxiety state (Subject's husband who has long re-cord of irresponsibility and indebtedness considered to be contributing factor.)

Subject employed in TM's office and SECRET clearance requested Feb 58 - clearance refused by DMI. Subject trans-ferred to non-sensitive position with Dept Northern Affairs.

Alcoholic Indebtedness

- a. Hospitalized in 1954 while in RCAF-"acute alcoholism".
- a. SECRET clearance granted by DMI 6 Jan 56-withdrawn 12 Jun 57
- b. Subject warned by Chief Clerk 14 May 57 re absenteeism due to suspected alcoholism, debts especially to fellow workers.
- b. Subject placed in position by DCP where he does NOT have access to classified information.
- c. Off-duty 16-29 May 57 medical cer-tificate diagnosis "acute alcoholism".
- c. Reports received May 58 indicates Subject member AA paying off debts and engaged to reliable govt employee.
- d. Investigation in May 57 revealed Subject had been giving unauthorized information to finance companies and that outstanding debts ammounted to \$1200.00.

CASE V

Criminal Record Drinking Indiscretion Debts

- a. Subject has police record of 10 convictions 1939-49 mainly theft, break and entry.
- b. Heavy drinker when drinking is boastful and indiscreet.
- c. Has had many employments indicating lack of stability.
- d. Lack of responsibility indicated by failure on several occasions to take proper care of wife and family.
- e. Considerable indebtedness.

Clearance to SECRET requested Sep 57 for employment JABC School-clearance refused by DMI. Subject transferred to non-sensitive position RCS of I.

CASE VI

Drinking

Since enlistment in Sep 51, Subject has the following record -1 charge under Liquor Control Act of Ontario (intoxicated in a public place) charges drunkenness charges AWOL charges conduct to the prejudice

Granted TOP SECRET in Jul 54. Due to subject's overindulgence in alcohol and fact that when under the influence of alcohol he becomes irresponsible - clearance reduced to CONFIDENTIAL May 57.

- a. During Army service Aug 51 -May 55, subject had 3 charges incl 2 of drunkenness.
- b. Oct 55 was fined \$200 and costs as a result of charge of criminal negligence arising out of an accident while driving when impaired.
- c. On re-enlistment Feb 56, PSO noted subject had an abnormal MMPI profile and was below normal in stability.
- d. Feb 57 Subject was charged with drunkenness and also with "negligent handling of dangerous substances.

ACTION

a. Subject was granted SECRET clearance during first enlistment.

b. SECRET clearance for Subject requested Dec 56 but clearance to CONFIDENTIAL only granted Suggested special report be submitted by subjects CO in 2 months time when up-grading of clearance would be reviewed.

CASE VIII

Morals Drinking

- a. Low moral reputation
- b. Persistent drinking although this has NOT interfered with her work and is considered discreet while "under the influence".

SECRET clearance requested for employment in CR.

DMT granted CONFIDENTIAL. Comd took action to restrict her access to that level and will transfer to unclassified work when opportunity arises.

CASE IX

Drinking Indiscreet A young woman (20) who drinks to excess and lacks discretion while "under the influence". SECRET clearance requested but only CONFIDENTIAL granted "at this time". Subject's employment restricted to handling material no higher than CONFIDENTIAL.

CASE I

Mental Illness

- a. Released from RCN (WREN) Nov 54 diagnosis "schizo-prenic reaction, paranoid type" extremely vulnerable to break-down under stress.
 - b. Four out of six previous employers would not recommend due to unsatisfactory service.

TOP SECRET requested for employment in highly sensitive position. Clearance refused and Subject released on adm grounds.
