Re: Security Screening of Government Employees - Character Weaknesses.

In compliance with the D.S.I's request contained in memo on the above, dated 27-11-62, the following questionaire is to be utilized by Investigators in A-3 Section, AT THE CONCLUSION OF EACH INTERVIEW.

It is not necessary that the exact wording as used here, be followed when presenting these questions to the interviewee, It is quite acceptable to change the wording as long as the original meaning of the question is not lost in the process.

- What is your personal impression of your family?
  - (a) Do you have any criticism of your parents as to the method by which you were raised? If so what was it?
  - (b) Do you have any criticism of the relation between yourself and your brothers and sisters? If so what are they?
  - (c) Do you in any way, lay blame unto your parents or members of your family for the personal character weaknesses, such as homosexuality, alcoholism, etc., that you may possess? If so why?
- 2. What is your personal attitude towards Society in General.
  - (a) Do you believe that society is entirely to blame or just partially for the impression that has been created towards homosexuality?
  - (b) Have you any personal criticisms of society's attitude towards homosexuality? If so what are these?
  - (c) Do you think this attitude could be corrected? If so, How?
- 3. What is your personal impression of other homosexuals?
  - (a) Do you resent other homosexuals and look upon them as being inferior to yourself?
  - (b) How would you react if blackmail was attempted upon yourself, now that you know the Force is aware of your tendencies?
  - (c) How would you have reacted prior to this interview, for while you were of the impression that this was still your secret?
  - (d) Do you think you would have sought outside counsel in either case?

Do you have any particular interests in current events as it affects the world situation?

(a) Do you have any interest or desire to travel abroad, if so why?

- (b) What is your preference in living accomodations, do you prefer living alone or with others, do you always pick the modern up to date dwellings, or do you look for cleanliness and reasonable rent?
- Do you prefer moving often, or establishing yourself on a more or less permanent basis at one address - why?
- What percentage of your total salary do you estimate that is invested in your living expenses?
- Do you experience any difficulty in meeting these financial obligations? Why?
- Do you like parties and if so, how often do you entertain?
- What do you estimate your average income to have been, since becoming a wage earner?
- What is your income estimated at, at the present time?
- As an associate of homosexuality, what places are known to you, as being regular gathering spots for this type of person, locally? List them.
- (a) Do you know of any such places outside Ottawa, if so, where are these located?
- Are you familiar to any extent, with any words or phrases that are frequently used by persons who are homosexually inclined? If so, list these words and their meanings to you.
- Have you ever resorted to or sought the advice of psychiatrists for your particular problems with homosexuality?
- Do you believe that you derived any benefit from these psychiatric sessions? If so, in what particular way?
- (b) Do you believe there is an ultimate solution towards a cure for homosexuality?
- (c) If so, by what method?
- (d) Do you think that a homosexual personally, has any control over these tendencies?
- Do you believe that homosexuals are born as such, or are these tendencies developed?
- Do you believe that the homosexual way of life is not abnormal, and should be accepted entirely by society? If so, what are your reasons?
- What would your solution be to the problem of older 10. homosexuals who often resorts towards the cultivation of children for personal homosexual relations?

The answers only to the above questions are to be embodied in the last paragraph of the "Information Section" of the individual report. The only reference required insofar as these questions are concerned, is the number and sub-number of each, which is to be obtained from the master sheet of questions retained by each investigator.

In the first paragraph of the "Investigator's Comments" portion of each report, the investigator is to include t his observations of the person being interviewed, which is to cover the following points:

- (a) The individual's reaction to the interview.
- (b) Was there any indications of tension, such as nervousness, sweating, mental confusion, etc.
- (c) The individuals attitude towards being interviewed - was he belligerent, indifferent, etc.
- (d) Did the interviewee appear proud or ashamed of his homosexual actions.
- (e) Make note of the questions which he has refused to answer and the reasons for each, if any.
