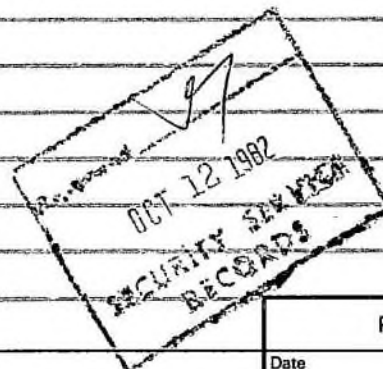

I have tabbed report of March 18, 1981 on IP371-32 for your consideration. We must continue to vigorously oppose the inclusion of sexual orientation in any proposed amendments to the Canadian Human Rights Act.

I agree with the comments of the O. i/c "A" Ops., memo 82-07-15. With specific references to page 4, points 4 and 5, as Chairman of the Advisory Committee on Records Policy we should have approved records schedules on homosexuals very soon. This will allow us to destroy all files on homosexuals that do not meet the requirements of our current mandate.

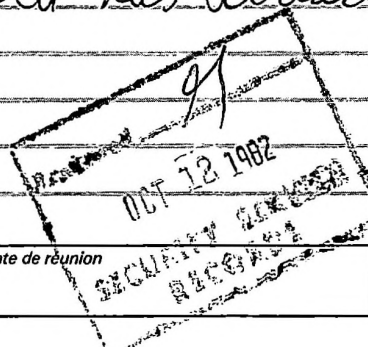
