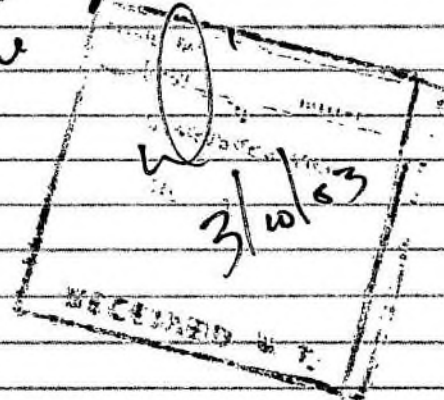

The Minister indicated that he was uncomfortable with the [REDACTED] case and specifically concerned about the letter written to him on August 22, 1983. The Minister asked how such a letter could get written and on what basis. For example, the Minister had previously indicated that homosexuality should not be identified as a weakness and it was not in conformity with Cabinet directives to so characterize it.

RCMP representatives indicated that the letter was seriously inaccurate in the references to CD 35, the consequences of CD 35 and the characterization of the individual's adverse information. It was agreed by the RCMP that another letter would be written to [REDACTED] by the Commissioner indicating that the letter was wrong and that he was requiring a review of the case. Subsequently a second letter will be written informing [REDACTED] of the results.
