F. CFAO 19-20

1. REF A ADVISED THAT POLICIES RESTRICTING THE SERVICE OF HOMOSEXUALS IN THE CF HAD BEEN FOUND CONTRARY TO THE CANADIAN CHARTER OF RIGHTS AND FREEDOMS AND THAT CFAO 19-20 AND ALL INTERIM POLICIES UNDER THAT ORDER WERE REVOKED IMMEDIATELY.

2. FOR PURPOSES OF CLARIFICATION, ONLY THOSE PORTIONS OF CFAO 19-20 AND THOSE INTERIM POLICIES DEALING WITH HOMOSEXUALITY HAVE BEEN REVOKED. CASES OF SEXUAL ABNORMALITY WILL CONTINUE TO BE DEALT WITH UNDER CFAO 19-20 PENDING PROMULGATION OF A REPLACEMENT CFAO.
